JOB DESCRIPTION

The Couples and Family Therapy program in the Department of Counseling Psychology and Human Services at the University of Oregon (UO) is seeking to hire a 9-month tenure-related faculty member. Applications from all academic ranks will be considered, but our preference is to hire a faculty member at the advanced assistant or early associate rank. The position will begin fall, 2011.

Candidates should have a program of research focusing on: (a) developing and evaluating evidence-based, family-related, and preventive interventions for disenfranchised and marginalized families, and/or (b) providing and evaluating cross-cultural interventions that cut across individual, family, and community levels (e.g., community and/or interpersonal violence, family conflict, enhancing parental roles, etc.). Clinical research on interventions that are ecologically and prevention-oriented, externally fundable, and that involve student training in the program's Center for Family Therapy is especially important.

Required Qualifications:

- Ph.D. in Marriage and Family Therapy from a COAMFTE accredited program, or Ph.D. in a closely related field with MFT training;
- Established record of scholarly productivity;
- Track record or potential for external funding, particularly through federal agencies;
- Program of research on: (a) developing and evaluating evidence-based, family-related, and preventive interventions for marginalized families, and/or (b) providing and evaluating cross-cultural interventions that cut across individual, family, and community levels (e.g., community and/or interpersonal violence prevention/intervention, family conflict, etc.);
- Ability to work in multi-culturally diverse settings with diverse populations;
- Ability to advise and supervise graduate student research;
- Ability to supervise graduate student clinical services;
- Licensed as a Marriage and Family Therapist in the state of Oregon (or eligible);
- Strong teaching skills and teaching experience in MFT and/or family systems curriculum;
- AAMFT Clinical Member and Approved Supervisor (or eligible);
- Ability to work in a collaborative and collegial manner with colleagues;

Preferred Qualifications:

- Experience or potential to work in or coordinate community-based intervention programs;

- Ability to assist in program administration, such as curriculum development and program director role;
- Evidence of interdisciplinary collaboration.

Responsibilities:

Conduct an active, externally funded research program; teach graduate courses; advise and supervise graduate student research and clinical work in the Center for Family Therapy; contribute to: (a) the implementation of the COE-wide diversity strategic plan, (b) program development and administration, (c) the department's focus on prevention science, (d) department, college, and university governance in a manner consistent with the needs of a major research university, and (e) departmental continuing education activities.

The Couples and Family Therapy program is an COAMFTE accredited program whose faculty are dedicated to enhancing multicultural competencies, promoting social justice, and promoting prevention science and practice. The program is housed in the Department of Counseling Psychology and Human Services, along with Counseling Psychology doctoral and Family and Human Services undergraduate programs.
