The George Mason University, Department of Global and Community Health seeks a full-time Term Assistant Professor of Community Health Promotion (nine-month, nontenure-track) starting January, 2016. Annual reappointments will depend on budget and performance

Responsibilities

Responsibilities include teaching undergraduate and graduate courses; participating in governance and outreach; and performing related assignments such as supervising senior projects, student internships and practicums, and student advising. Selected candidates will be expected to teach four courses per semester in: introduction to public health, health behavior theories, public health promotion methods, health planning and evaluation, and public health leadership and advocacy.

Qualifications

Successful candidates will have a doctoral degree in public health or a related field. MPH or MSPH and previous work experience is preferred. Ideal candidates will have a record of effective teaching. Experience with teaching online is further preferred.

Mason is one of the fastest growing universities in the country and has a national reputation for innovation in higher education. The university holds a top *U.S. News and World Report* "Up and Coming" spot for national universities, and is recognized for its global appeal and excellence in higher education.
